RULES AND REGULATIONS

1. Each team must have a team name (be creative). **Costumes are encouraged** (this is a family event, judge could disqualify).
2. There will be a women's and a men's class. 3 people per team.
3. Teams will start and stop at the sound of the whistle.
4. Each team member must have 1 (one) hand on the painted area of the fence before the sound of the whistle.
5. A team has 45 seconds to put the pig into the barrel.
6. Contestants can use only their arms and hands for the wrestle. **The pigs' ears, snout and tail are off limits.**
7. Pig must go into barrel **TAIL** first and each member of the team must have 1 (one) hand on the pig as it goes into the barrel.
8. **ABSOLUTELY NO** abuse or roughing of the pig will be tolerated. Time will be stopped if the judge feels the pig is in trouble.
9. All team members must be present at 6:30 pm at the ring for a meeting, or forfeit.
10. Judge's decision is **FINAL!**
11. **NO REFUNDS.**
